1) What are the official dates of the 7th GCBSS 2018?

Two types of parallel presentations: Abstract based presentation duration is 10-12 Minutes including Discussions. Full paper based presentation duration is 15-20 Minutes including Discussions.

19) Will I receive my registration materials in the mail?

20) Can I register for a day only?

We do not allow day registration. You need to pay full registration fee but you can stay a day.

Substitutions are allowed with the written authorization of the registrant who is unable to attend. You must notify us by email at least 48 hrs. In advance of the conference if you wish to send a substitute participant. 22) If I am unable to attend the conference, how do I cancel my Registration?

You may cancel without penalty if written cancellation request are received up to and including 45 days prior to the start of the conference and get full fee credit voucher. A credit voucher less 50% of the registration fee will be issued for written requests received up to and including 25 days prior to the start of the conference. No refunds or credits will be issued on cancellation requests received

23) Can Lecturer/employed cum Student can pay student fee?

24) Can lead author request for additional certificate for his co-author?

For additional Certificates for co-authors needs to pay USD 100 for each additional certificate.

PUBLICATION

25) I have submitted only abstract and when should I submit Full Paper Now? Can I change the name of the author or paper title after I submit the paper? Can I change the title and author's name in the draft conference program?

You can submit full paper before the submission deadline. You can make changes with the approval of organizing committee before the publication of final manuscript. For inquiry: admin@gcbss.org

27) Can I use my paper in some other conference at same time?

No, Papers should be original contributions and should not be under consideration for any other conference or publication at the same time.

28) Is there any page length limit for journal/conference papers?

Yes. Pages limit vary publisher to publisher, organizing committee advice to prepare full paper between 8 pages (including reference and figures) in length.

29) What if my paper exceed from 8 pages?

If the length exceeds from 8 pages, the authors are required to pay a publication fees of USD 25. (But take prior permission from Guest Editor).

30) What format is required for the submission of paper?

Abstracts/full Papers must be in doc/docx format through online registration form [Please click here](#) and submitted through electronically email at submission@gcbss.org

31) How many authors are allowed in each manuscript?

If number of authors are more than two in the manuscript authors are required to pay additional fees USD 50 for each additional author name.

32) What are the criteria of selection of conference papers for Journal publication?

Conference would accept all types of papers with innovative ideas and recognized as outstanding papers among the review committee. All accepted full Papers will be published in the regular/special issue of the high indexed journals.

33) Where is the conference proceedings/journal articles indexed in?

All accepted papers will be published in the regular/special issue of the Journals indexed in **ISI (Thomson Reuters)** and **SOPOUS (Elsevier)**. For more details please visit [Publication Opportunity](#).

34) Is there any print journal copy of the publication?

Yes. Few journals also offer print copy that cost USD 25 per journal copy. Authors, normally communicate once their publication finalized.

35) Is there any authorship fee involved in Scopus publication?

Yes. First and Second authors need to pay regular conference fee. Each subsequent author need to pay USD 50 as a authorship fees.

36) Is there any authorship fee involved in Non-Scopus publication?

No. lead author needs to pay regular conference fee only. If number of authors are more than two in the manuscript authors are required to pay additional fees USD 50 for each additional author name.
